ABOUT YMCA

- ❖ There are about 1000 YMCAs in India
- ❖ The first college of physical Education in India was started by YMCA at Chennai in 1920.
- ❖ Basket ball was invented by J. Nasmith in 1891 at Springfield YMCA college, USA
- ❖ Volley ball was invented in 1895 by a YMCA member Mr. G. Morgan.
- ❖ The Indian contingent for the first time in 1924 to the Paris Olympic was selected and trained by the Indian YMCA. Mr. H. C. Buck of the YMCA School of Physical Education was the Manager and Coach of the contingent.
- ❖ "Rules of Games and Sports" also known as "Buck Rules" was first published by YMCA which is still the basic rules book in India.
- ❖ The YMCA developed rural demonstration centers as early as 1918. The term "Rural Reconstruction" was coined by YMCA.
- ❖ The Rural Co-operatives were organized initially by the YMCA.
- ❖ The YMCA was the first to organize Night school for working young men.
- ❖ The first Boy's town in India among the vagrant boys was introduced by the Madras YMCA.
- ❖ The YMCA paved the way for SCM, Ecumenical Movement and the YWCA.

- ❖ YMCA Cuttack was established in 1893.
- ❖ Utkal Gaurav Madhusudan Das took main initiative to form Cuttack YMCA.
- ❖ Leaders like Mr. Biju Patnaik, Col. Sangram Keshari Roy, Mr. James Dharmaraj, Mr. E.B. Samuel and Rai Bahadur Samuel Das were the key persons behind development of Cuttack YMCA.
- ❖ Cuttack YMCA provides hostel facilities for students and working persons at very nominal price.
- ❖ Cuttack YMCA conducts various programs for the society at its Old Secretariat road Building. Cuttack YMCA provides games & sports facility in Table Tennis, Badminton, Karate etc. Cuttack YMCA pioneered in facilitating table tennis & badminton in Odisha.
- ❖ BHAGATPUR PROJECT CENTRE is a major project of Cuttack YMCA under its Rural Development Programs at Bhagatpur, Cuttack.

CODE OF CONDUCT

- ❖ **Code of Conduct** - Members are expected to behave in a mature and responsible way and to respect the rights and dignity of others. The YMCA does not permit language or any action that would tend to hurt or intimidates another person, including staff or that falls below a generally standard of conduct.
- ❖ All members are required to present a valid membership card for identification when using YMCA facilities and participating in YMCA programs.
- ❖ Membership privileges and cards are not transferable, will remain the property of the YMCA Cuttack and must be returned upon request.
- ❖ **Drug, Tobacco and alcohol free** - The use of illegal and recreational drugs, tobacco and on YMCA Premises is prohibited. Members should refrain from coming to YMCA facilities if they are under influence of prohibited substances.
- ❖ **Lost/Stolen Property** - The YMCA Cuttack will not be liable for lost or stolen items while members are on YMCA premises or engaged in YMCA activities. Members and guests are responsible for their own possessions. Valuables should be left at home or in a secure place.
- ❖ **Lost & Found** - Items that are found and turned in are kept at GENERAL SECRETARY Office. Such unclaimed articles may be donated for charity purpose.
- ❖ **Safety** - The YMCA is committed for providing a safe and welcoming environment for every member and guest. To promote safety and comfort for all, we ask individuals to act appropriately at all times when they are in the YMCA facilities or participating in YMCA of programs.
- ❖ **Sexual Offender/Criminal Background Check Policy** - We consider it of great importance to provide a safe and threat-free environment. The YMCA reserves the right to deny access or membership to any person who has been charged with or convicted of any crime involving sexual abuse or who is required by law to register as a sex offender. Registered sex offenders and those individuals with any criminal conviction for an act is contrary to the YMCA values and mission may not be eligible to hold membership.
- ❖ **Weapons** - Possession, sale, distribution or carrying of weapons, including guns, knives and explosives are prohibited and will result in an immediate dismissal from the premise and possibly cancellation of a membership.
- ❖ **Termination** - The Board of Directors reserve the right to suspend membership of any member whose conduct and behavior is found detrimental to the aims and objectives of the Association.
- ❖ If membership is terminated within 30 days of joining, the member will receive a full refund of the membership fees after deducting the administrative expenses. Refund are not available for members who have already completed 30 days of membership with YMCA Cuttack.

TERMS & CONDITIONS

- ❖ Members of the YMCA agree to abide by the rules, policies and code of conduct including changes approved by its board in accordance with its bye-laws.
- ❖ **RELEASE AND WAIVE OF LIABILITY AND INDEMNITY AGREEMENT** - In consideration of being permitted to participate in YMCA programs and use YMCA facilities and services (collectively, the "Activities"). I undersigned, agree as follows: I understand and acknowledge that the Activities involve certain known and unanticipated risks that could result in injury or death to me or others, and/or damage to property belonging to me or others. I agree that I am in good health, with no physical conditions that might cause injury to me, and that I am able to handle the risks associated with the Activities. I warrant that I have inspected the YMCA's premises and all facilities and equipment thereon (hereafter "Premises") and accept them as being safe and reasonably suited for the Activities!
- ❖ I hereby voluntarily release and forever discharge the YMCA, its directors, officers, agent) and employees, from any and all claims, demands, actions, and/or liabilities based on or arising from injury, loss, damage death to me or others or to property belonging to me or others (collectively, "Claims"). Caused by or sustained in connection with my use of the Premises or my participation in the Activities, regardless of where such Claims arise, including but not limited to any and all Claims based on or arising from the negligent acts or omissions of the YMCA, its directors, officers, agents, or employees, or any other persons or entities.
- ❖ I promise not to sue or otherwise maintain or assert any Claim against the YMCA, its directors, officers, agents, or employees, for any injury, loss, damage or death to me or others property with my use of the Premises or my participation in the Activities.
- ❖ I agree that I will indemnify the YMCA for the defense of any such Claims asserted by me or others, [including reasonable attorneys' fees and costs), and for any liabilities based on or arising from such Claims.
- ❖ I recognize that if anyone is injured or dies or if any property is damaged while I am on the premises and/or engaged in the activities, I will have no right to make a claim or file a lawsuit against the YMCA, or its directors, officers, agents, or employees, even if they or any of them negligently caused the injury, death, or property damage.
- ❖ **ENTIRE AGREEMENT** - I understand that this is the entire agreement between myself and the YMCA, its directors, officers, agents, and employees, and that it cannot be modified or changed in any way by the representations or statements of any employee or agent of the YMCA or by me. I agree that no oral representations, statements, or inducements, apart from the foregoing written Agreement, have been made to me.
- ❖ **ACCEPTANCE** - I have carefully read and fully understand the above conditions of membership and release, waiver of liability, and Indemnification agreement, and accept the terms of membership set forth above and in the membership policy, I am fully aware that this is a legal document with legal consequences I am giving up rights I may otherwise have.
- ❖ **LIKENESS/PUBLICITY/CONTRACT CONSENT** - I give my permission to the YMCA Cuttack to use, without any obligation to me, photographs, film footage or tape recordings that include the image or voice of me or my family for purposes of promoting YMCA programs and to contact me with news and promotions.
- ❖ **SERVERABILITY** - I understand and agree that the foregoing Release, Waiver of Liability, and Indemnification Agreement is intended to be as broad and inclusive as permitted under the law of India, and that if any portion of the Agreement is held invalid, the remainder of the Agreement shall continue in full force and effect.
